

# MID-TERM NEEDS | NOTEWORTHY ITEMS


- Method of Analysis and Presentation



# MID-TERM NEEDS | NOTEWORTHY ITEMS

- Location of a Need may not necessarily be same as the location of the solution
  - A solution to a Need may be elsewhere on the same facility or on a parallel facility



# MID-TERM NEEDS | NOTEWORTHY ITEMS

- Needs are not solutions
  - A highway Congestion or Reliability Need could be addressed by a highway project, rail or transit services, and/or policy solutions.



# MID-TERM NEEDS ASSESSMENT | NOTEWORTHY ITEMS

- Consider taking a comprehensive view of the Mid-term Needs
  - Key Question "How can I develop a strong project funding application?"
  - Review and identify intersections, segments, and areas that have multiple Needs
    - Example: Safety Needs AND Reliability Need

# **VTRANS MID-TERM NEEDS I PUBLIC & AGENCY FEEDBACK**

- We received approximately 125 comments that include:
  - Add more Needs
  - Analyze accessibility and mobility needs outside of Regional Networks and Corridors of Statewide Significance
  - Provide CoSS designation for additional routes
  - Make SMART SCALE screening determinations
  - Modify VTrans Needs to ensure SMART SCALE High Priority Projects Program (HPPP) funding eligibility
  - Other
